Creating The Difference In A Competitive Market / Implant Complications: Problem or Opportunity? Teaching Method: Lecture



Gregory A. Toback, DMD, MS

Gregory Toback, DMD, MS is a periodontist practicing in New London, CT and is the CEO of Shoreline Periodontics. He received his B.S. from St. John's University (cum laude), and his DMD from UCONN

in 1995 (Award for Excellence in Restorative and Prosthetic Dentistry). Following completion of his dental degree, Dr. Toback pursued advanced training in periodontics and dental implants at the University of Texas Health Science Center in San Antonio.

Dr. Toback is a diplomate of the American Board of Periodontology. He is also a clinical professor at UCONN School of Dental Medicine and has authored papers in major periodontal and dental implant journals. He lectures extensively on a variety of clinical topics including dental implants, bone and soft tissue regeneration, laser periodontal therapy and implant complications.

Dr. Toback has lectured on the subject of "The Business of Periodontics" since 2010, and has become a highly requested speaker on this topic. He has lectured for the Academy of Periodontology, the Midwest Society, the California Society, the Southern Academy and others. He is the founder and CEO of HP₃: High Performance Perio Practice which is a consulting business featuring an intense 12-month mentoring business program for periodontists.

Dr. Toback is a clinical investigator of the prestigious McGuire

Institute which focuses on delivering highly relevant clinical research that supports new and improved technologies that benefit patients. In 2017, together with an esteemed group of private practice investigators, he was awarded the AAP Clinical Research Award.

Creating The Difference In A **Competitive Market Abstract:**

In the morning, we will explore the changing dental industry and explore the vulnerability/ opportunity of periodontics in the current landscape. We will explore foundational principles of management based on efficient systems that deliver exceptional patient experience. In addition, strategies for creative and unique marketing will be discussed to define and differentiate ourselves in a competitive industry.

Educational Objectives:

- 1. Understand the economic pressures shaping the dental industry
- 2. Describe the "entrepreneurial mindset" that will allow periodontist business owners to position their organization in the new market
- 3. Present examples of strategic marketing campaigns and how to measure response

Implant Complications: **Problem or Opportunity?** Abstract:

In the afternoon, we will tackle implant complications. Categorization and organization of types of implant afflictions will be reviewed. Decision trees for available therapies will be explored. Finally, we will visit

the question of whether implant complications are a problem, or an opportunity for periodontal specialists. Is there an opportunity for periodontists to concentrate efforts in this area and build their practice through this focus? We will discuss and debate this very topic.

Educational Objectives:

- 1. Review current classification of implant complications and periimplant disease.
- 2. Understand the etiologies of periimplant inflammation and attachment loss.
- 3. Review the risk factors that may play a role in peri-implant disease.
- 4. Present available treatment options and provide a basis for decision making on which approaches will be most predictable in achieving desired clinical results. Emphasis on non-surgical therapy, incisional surgery and laser implant surgery will be explored.
- 5. How to position yourself as the specialist for implant complications and the preferred provider for future treatment.
